EXECUTIVE SUMMARY

1.0 INTRODUCTION

1.1 Background study

Blender is a mechanical appliance in the shape of a platform designed with a spinning knife used to blend, mix, grill or stack food ingredients. It is typically used in the kitchen or at the pub. Blender was invented in 1922 when a Polish-American interviewer named Stephen J. Poplawski was the first person to place a spinning knife in the bottom-of-the-platform for the first blender. He used it to make malt and milkshake, and then attempted to market his results to the drug store owner. In 1932, Poplawski issued patent rights to combine his idea, which could also be used for fruit and vegetables. Until you can see, the best blender of the time was used for all kinds of things, much as today. In 1937, Osius completed the Poplawski blender and labeled him Mixer Wonder. Osius replaced his product name with Blender Waring. For having a difference with Osius, six months later Fred Waring ended his collaboration with Osius and set up his own business, Waring Corporation. In the same year, he launched warring Blender at the National Restaurant Show in Chicago and sold it for US\$ 29.75. Blender Waring has been globally famous in the United States and is known to be one of the finest blenders on the market. The sales of Waring blender amounted to one million in 1954. In 1946, John Oster decided to diversify his efforts from gross appliances to household appliances by buying Stevens Electric, a business self-esteemed by Stephen Poplawski, the first blender interviewer. Immediately after that, the Osterizer blender was first introduced. The blender is capable of dealing with the Fred Waring blender.

1.2 Problem Statement

Technological development has contributed to the growth of more sophisticated products. As a result, products produced by companies and industries are increasing day by day, making products grow rapidly on the basis of the present trends and quality.
