

## ABSTRACT

In the year of 2013, statistic reveals that the total of RM66.6 billion worth of asset and property left behind by the deceased remained unclaimed and unsolved cases related to property cases and it keep increasing year by year (Utusan Malaysia (2013,September 11) RM66.6 Bilion Tidak Dituntut Retrieved from: (Zin, Utusan Malaysia, 2013). The increasing number of frozen asset or unclaimed property had call for a need to introduce an alternative instrument or tools in order to help distributing Muslim's wealth. As-Salihin Trustee Berhad as one of the Islamic estate institution had provides an initiative as an alternative in order to help Muslim in their wealth. The purpose of this research is to analyze the level of understanding among student of Muamalat about hibah and wasiat.
