ABSTRACT

Shariah Compliant Hotel can be defined as a hotel that provides services in accordance to the Shariah principles. In total of 112 valid respondents of the guest of Shariah Compliant Hotel in Kuala Lumpur, Negeri Sembilan and Selangor were analyzed in order to achieve research objective.
