Strata Titles is a form of ownership of structures or blocks constructed on alienated land with multi-storey or multi-level land parcels. The term' Strata ' refers to the unit being subdivided. On the other hand, the delay issues that influence to provide transference of strata title for tenant become a major problem and be the question of the effective system for application strata title in Malaysia.
