Introduction

Islamic By-Laws executed by local government at Kelantan: Learning Referral is about the innovation products that has been created from the internal grants dispensed by the Faculty of Administrative Science and Policy Studies (FSPPP) Universiti Teknologi MARA (UiTM) 2021. From the grant, several publications have been made and joining innovation competitions such as International Invention & Innovative Competition (InIIC) 2022 and International Creative Innovation Idea Competition (ICIIC) 2023. The innovation started with the project called By-Laws Potrayal: Local Authority Exertion. The innovation is in the form of an infographic poster created with the compilation of an insightful local government by law information that have Islamic approach consisting of related pictures, findings of local authorities views and others information related that purposely related for providing the needed information for the local communities at Kelantan. The second innovation is in a form of a book named By-Laws Influence in Shaping the Society's Behavior - A Monograph which is a simple but extensive book created with the compilation of an insightful local government Islamic by-laws implementation.

This study is based on the second innovation that focused on students' learning aids needed to understand the local government subject offered to Faculty of Administrative Science and Policy Studies (FSPPP) students for Diploma in Public Administration students. With the creation of the book, it would help students to have a better insight regarding the implementation of Islamic by-laws by the local government in Kelantan. The book is explicitly designed to provide students with Islamic by-laws piece of information with vibrant details using the specified illustration related with the implementation of the local government.

By-Laws is defined as the subsidiary legislation of the principal law and enacted for the local authority's jurisdiction in performing their duties and functions. This subsidiary legislation is also known as Orders, Rules and so on (mpkbbri. gov.my). The local authority has jurisdiction to enforce a rule known as by-law based on an emphasis on three major aspects namely public health, community safety and the well-being of the local community (Khairul Azhar Meerangani, 2018). By-laws are the jurisdiction granted for local governments according to the Local Government Act 171 (1976). This means that local governments have the power to identify and enact appropriate by-laws in ensuring the smooth running of their administration areas.

By-laws are created to play a vital part in affecting the daily lives of societies; especially in local government areas which have quite different approaches such as Kota Bharu Municipal Council of Islamic Cities (MPKB-BRI) and other local governments in Kelantan. By-laws implemented by the local government at Kelantan is quite different compared to other local governments in Malaysia due to the provisions of the by-laws that have an Islamic approach which has given some positive impact to the local communities especially in shaping the society's behaviour. The local government has outlined a clear and distinct interpretation of aurat (Suhana & Marsitah, 2015). MPKB by-laws (Amendment 2004) explained that the interpretation of 'aurat' means the whole body of a woman apart from the face and both hands (Suzei Mat Nurudin et al., 2018). It is detailed in the implementation that for Muslim traders, they need to cover their aurat accordingly to the Islamic practice and for

non-Muslim traders; they also need to wear their attires appropriately.

This study focused on the guidelines available to grasp the substance of local government by-laws that focused on Islamic approach in Kelantan and assist the students to improve their knowledge on the subject matter. Besides that, they can also do quick revisions in an interesting way by referring to the examples enlisted in the book.




Figure 1: Monograph front page (Sources: Suzei et al, 2023)

Innovation Objectives

The study has identified some objectives as listed below:

1) To guide students to get a better understanding on the concept and implementation of local government bylaws with Islamic approach by exploring the book.

2) To guide students by providing definite examples through the local community's feedback.

3) To facilitate students to learn and understand the content of the local government's by laws by providing insightful information from the book.

Local government administration is a core subject for final year students pursuing a Diploma in Public Administration, FSPPP, UiTM. It is a requirement that students have to pass the subject in order to graduate on time. Hopefully with the creation of the By-Laws Influence in Shaping the Society's Behavior – A Monograph, would help to accomplish these objectives.

Problem Statement

The influence of the environment as well as the rapid development in modern technology have provided challenges in applying shariah-compliant dress practices to Muslims (Muhammad Khairul Nizam et al., 2019). It has become an obstacle for the local government to manage the issue of the code of ethics for compliant dressing according to shariah (Rasyidah, 2017). The Kelantan government found the level of adherence to proper dress code among women in the state still unsatisfactory even though it has been implemented for almost 20 years (Mohd Azhar & Raihanah, 2010). Local authorities in Kelantan have been enforcing the Islamic dress code in stages beginning with people who are involved in business because these people are always interacting with other people. The local authority had also introduced 'Operasi Gempur Aurat' and imposed a fine of RM500 to those found guilty of not covering their aurat accordingly.

A study by Mohd Fadhil (2011) stated that some of the communities in Kota Bharu did not comply with the image of a Muslim community. Abdul Aziz Yusof (2012) asserted that the effort to develop the ummah should involve the development of spiritual, physical, mental and morality, coinciding with the concept of compliance applied by the state government. The findings of his study also found that there were many Muslims in Kelantan who still did not comply with the Islamic dress code. Murtopo (2017) stated that many women in show casting have the tendency of not covering the aurat properly by using mini hijab and thigh outfit. This practice is a symptom that cannot be avoided by modern society today. Based on these problems, the local government in Kelantan has come out with the Islamic by-laws and at the same time, reshaping the behaviour of the local communities.

In conjunction with the innovation product, as identified by Nor Suhaiza, Suzei and Zarina, (2017), students faced difficulties to comprehend the content of local government subject. Lacking definite examples of the practice may lead to poor understanding on the local government subject and students can't score well in this course. The lack of definite examples related to the local government content has caused problems to students as they did not have any suitable reference for their revision.

Students have problems to learn in depth on the course by just solely listening to lectures given. So additional tools are needed to help students to learn with the aid of additional references while revising the lecture's notes (Suzei, Nor Suhaiza & Zarina, 2020). This study has identified definite examples that can be used as reference aid while learning this subject. It is hoped, by developing this product, it may become an effective learning aid for students to study and revise the local government subject.




Figure 13: Info Graphic 3 (Survey Discourse) (Sources: Suzei, Dr. Zarina & Rasukhan, 2022)
