ABSTRACT

This paper discusses the establishment of the UiTM Street Law project in Malaysia and the launch of the UiTM Street Law Portal, which aims to educate the public about law and government through interactive teaching methods. Inspired by international Street Law movements, the UiTM Street Law programme aims to fill the gap in legal education initiatives within Malaysian law schools. While Malaysia has active community legal services, they do not resemble the comprehensive operations of the Street Law movement. To address this, the UiTM Street Law movement was founded to provide open-source legal materials and pro-bono education online. The project seeks to reach marginalized groups and offers core law subjects like contract law and constitutional law on the UiTM Street Law Portal. The portal includes interactive features for communication and scheduling pro-bono legal teachings. The project aligns with the Sustainable Development Goals of reducing inequality and



promoting peace, justice, and strong institutions. By promoting access to legal knowledge and empowering marginalised communities, the UiTM Street Law project aims to contribute to a more equitable society and strengthen the justice system.

INTRODUCTION

The Street Law movement is an international educational initiative that aims to promote legal literacy and empower individuals with a better understanding of law and government. It originated in the United States in 1972 (Pinder, 1988). The movement has spread to countries like the United Kingdom, Europe, and Australia. Street Law programmes use interactive teaching methods to engage ordinary people and educate them on legal concepts, rights, and responsibilities (Blackburn, 2023).

These programmes involve collaboration between law students, legal professionals, and educators to develop and deliver legal education curricula in community settings. Through workshops, mock trials, and role-plays, participants gain practical legal knowledge and learn about their rights and the legal system (MacDowell, 2007).

The core principle of Street Law is to empower individuals to navigate legal issues and make informed decisions. By simplifying complex legal concepts and fostering critical thinking, Street Law increases legal awareness, promotes access to justice, and encourages civic engagement (Arbetman et. al, 1999).

Street Law initiatives have a profound impact on individuals and communities, levelling the playing field, reducing inequality, and fostering a sense of justice and empowerment. They also promote active participation in democratic processes by informing individuals about their rights and responsibilities as citizens (Arthurs, 2015).




Figure 1. Navigation Bar/Dropdown Menu with UiTM Street Law Logo




Figure 3. Content Resources including e-books, guides and tutorials, videos or webinars, archives and blog
