### ABSTRACT

#### **CHAPTER 1**

#### **1.1 INTRODUCTION**

### 2.2 Divorce from Traditional Malaysian Perspective

Divorce do happens and it can happen to anyone without discrimination through ethnics, contexts and cultures. People tend to see a divorcing case as a negative things happened to them. Generally, the perception about divorce in most societies tends to be one-sided because it has been associated with negative impacts to the divorcee. A pool of resources from Malaysian literature such as newspapers, local journal articles, and Malay studies provide information on the definition of divorce, the main causes for divorce, popular reasons to file for divorce, and the consequences of divorce (Chan and Mustaffa, 2008; New Straits Times, 2011).

Malaysian people see divorcing as a social taboo and most of them blame the wives for divorcing. This perspectives leads to the stereotypes and prejudices issue in our society. According to Kassim 2011, they were generally perceived as those who did not know how to take care of their spouses (Kassim, 2007). The wives always be the one that get blame for not taking care of their husband and they become the main reason why the divorce happen. This situation is quiet unfair for the wives because the reason of divorcing is not only comes from wives but husband also contributes the reason why they getting divorce.
