Within the complex socio-political environment of the Palestinian territories, women have become key sources of resilience in the face of protracted conflict. Palestinian women demonstrate incredible tenacity in sustaining not only their families but also their communities and cultural traditions by enduring the difficulties of occupation and ongoing warfare.

Violence can profoundly alter the physical environment it touches and have enduring impacts. According to one perspective, it's a spatial activity wherein some groups subjugate others. Armed groups could employ violent techniques to control or occupy specific regions, transforming them into hubs of power struggles. Lefebvre (1991) asserted that violent episodes are more likely to occur in contexts with obvious imbalances. Through the power establishment of "no-go" regions that people are frightened to visit and the continued marginalisation of already marginalised groups, these acts have the potential to

exacerbate spatial injustices. Lefebvre underlines how crucial it is to understand power dynamics, social practices, and the meanings associated with places when examining how violence alters physical spaces.

The role of Palestinian women is defined by their strong participation in political and social activities. They fiercely defend their rights as well as the rights of their Many communities. have taken leadership positions in human rights organizations, political parties. and grassroots movements, greatly advancing the continuous fight for justice and equality.

Palestinian women face particular difficulties as a result of the Israeli-Palestinian conflict, including travel limitations, financial challenges, and violence exposure. Their tenacity in facing these obstacles emphasizes how urgent an end to the protracted conflict is.



The conflict has a significant social and economic impact on women's lives, limiting their access to jobs, healthcare, and educational opportunities. Consequently, women encounter more difficulties in supporting their families and guaranteeing the welfare of their offspring. Nonetheless, Palestinian women have not been helpless victims; rather, they have actively participated in a variety of political activity campaigns, fighting for their rights and advancing the larger cause of self-determination.

Regrettably, gender-based violence often escalates in war areas, disproportionately affecting women. This covers incidents of sexual assault, abuse, and exploitation. While the visuals of deceased bodies effectively illustrate the impacts of endemic violence, the story primarily focuses on the living bodies burdened by the consequences of a space fundamentally altered by violence. These living bodies are used as puppets in the pervasive realm of material and discursive violence. where thev manipulated and subjugated (Braidotti 2016, pp. 77–78).

The notion that memory is a repository for violence focuses on the psychological and cultural aspects of how violent crimes from the past are remembered and transmitted across the generations. These concepts offer perceptive insights into the complex interrelationships that contemporary society has between violence, memory, and space.

These narratives often turn the body into an epigraphic space where violence is internalised by using it as a canvas on which the structural and subjective violence of their surroundings is written (Braidotti 2016, p. 76).

Women are essential as heritage guardians in the intricately woven cultural traditions that make up Palestinian society. Tradition and progress continue to interact. For Palestinian women working towards addressing laws that discriminate against them and removing obstacles to economic engagement continue to be priorities. Their actions help change social mores and create an atmosphere encouraging women's emancipation.

Among the notable contributions made by Palestinian women to the arts, literature, and cultural expression are their creative undertakings. They contribute to the worldwide conversation on culture and resilience by offering a distinctive viewpoint on the Palestinian experience, both inside and outside of their own country, through poetry, prose, and visual arts.

In these communities, women face challenges such as resource scarcity, displacement, and the constant battle to preserve their sense of self and identity in the face of hardship.

Understanding Palestinian women's diverse roles and experiences is essential to comprehensively understand the region's broader social, cultural, and political dynamics. Their resilience, activism, and contributions are integral to the ongoing narrative of the Palestinian people.
