The musical process originates with the composer’s ideas and experiences, influenced by the era in which he or she lives. By manipulating the materials of music-rhythm, melody, texture and expression- into a coherent form, the composer constructs a framework to support his or her creative ideas. Then using the notation, composers put their ideas on paper. Notation is a system of visual symbols that represents sounds and sound qualities. Performers can then read and interpret these symbols and recreate the composer’s ideas through the performance medium – the voices or instruments.
